# VOTE FOR THE NATIONAL BOYCOTT AND TOTAL MOBILISATION ON APRIL 28



Vote to support the boycott and mobilisation at the general meeting on your campus.

- That, in view of the success of the September 30, 1976 strike and mobilisations, and the continuing attacks by the Fraser Government on education spending, a one day national boycott and total mobilisation of Australian post-secondary students be held on Thursday, April 28.
- 2. That nationwide demonstrations be held to coincide with the national boycott and total mobilisation.
- 3. AUS recognises that the object of the boycott and total mobilisation is the Government rather than the staff (academic and non-academic) of educational institutions, and therefore instructs the organisers of the activities of the boycott and total mobilisation to do their utmost to enlist the support of all staff and students.
- 4. That the boycott and national mobilisations and demonstrations have as their demands:
- i) a living wage for all students;
- ii) no cutbacks in education spending; a real increase in Government education funding;
- iii) no tuition fees:
- iv) the immediate increases of TEAS payments to 120% of the Henderson poverty line;
- v) no restrictions on eligibility for TEAS: TEAS made available to all students (including Aborigines);
- vi) no government-controlled loans scheme;
- vii) no restructuring of education to serve the interests of the employers.
- 5. Further, AUS fully supports any activist victimised for working for the boycott and total mobilisation or for striking, and AUS demands that students be able to defend their interests without academic or other penalisation.

AUS MOTIONS GE.R. 10:77 "Means Test that education is a right and not a privilege and that it is the responsibility of the Government to pay, and not the individual, AUS demands that the means test be abolished as it discriminates against many students in need, is based on the principle of assistance and does not in reality make education to working class people accordingly. Thus, AUS believes that the following changes to the TEAS scheme must be made immediately to alleviate the critical material poverty of students: Abolition of all restrictions on eligibility for TEAS, so that all students receive the same level of TEAS income ii) Income to dependent sexual partner be equivalent to the Henderson poverty line, and income to dependent child be equivalent to half the Henderson poverty line, both to be indexed in the same manner as other social service benefits." The above is policy passed at Annual Council 1977 moved to Constituent Ratification. To be defeated, the above ER requires in excess of 50% of exercisable votes cast against." Foreshadowed Motion - This will be voted on if E.R. 10:77 is lost. E.R. 11:77 "Means Test All students, independent of their acadamic record or enrolment status, who have been accepted to study at an approved post secondary institution, should receive a TEAS allowance, subject to a means test based on parental income, which should be applied according to the following conditions: that maximum independent allowances be paid to: full time students over twenty one years living away from home full time students under twenty one years **b**) living away from home, consequent on their production of evidence that they receive no financial support in excess of \$2,000 per annum any students living at or away from home who can prove need by submission to a Students Assistance Review Tribunal, of which at least 50% of the members are students! representative elected by students; ii) that the maximum dependent rate of allowances be two-thirds of the independent rate; iii) that student couples, regardless of sexuality or legal contract, are eligible to receive two full independent allowances; iv) that students who are married or in de facto relationships receive the maximum independent allowance regardless of the income of their spouse or partner;

v) that the initial parental income level adjusted for the number of dependants according to the guidelines of the Williams Committee for the application of the means test to the average weekly earnings for a single adult where one parent is employed and be 1.5 times the average weekly earnings per annum for a single adult, in cases where both parents are employed; vi) that the abatement rate of \$2 in every \$10 per annum for which joint parental income is in excess of the cut-off point; vii)that other awards, benefits or grants whose total does not exceed \$1,500 be excluded from the independent rate." E.R. 12177 (re mobilisation Thursday April 28th) "1. That in view of the success of the September 30,1976 strike and-mobilisations, and the continuing attacks by the Fraser Government on education spending, a one day national boycott and total mobilisation of Australian post-secondary students be held-on Thursday, April 28. 2. Further, AUS fully supports any activist victimised for working for the boycott and total mobilisation or for striking, and AUS demands that students be able to defend their interests without academic or other penalisation." The above policy is passed at Annual Council 1977 moved to Constituent Ratification. The above ER requires in excess of 50% of excreisable votes cast against, to be defeated.

E.R. 13:77 "That AUS Annual Council 1977 endorse the attitudes expressed in the Planning Committee Report and Position Paper 5 against the introduction of the practice of direct elections of AUS Officers, noting;

i) that the present collegiate system is the most democratic for AUS as a federation of constituent organisations

ii) the necessity of student membership to review the performance and policies of candidates for elections

iii) the undesirability of the domination of the Union's time and resources by a direct election process, and noting that its implementation would require financial resource which the Union does not currently possess

tv) the present system where Officers are responsible to AUS Council and accountable to it for the observance of AUS policy should not be replaced by a system where the Officers could legitimately claim accountability and responsibility to either of two bodies (Council or their particular electorate)

v) the proposal represents a vote of no confidence in the ability of elected delegates to Council to carry out their

responsibilities

vi) that this Council believes it is more important to involve AUS membership in policy making through ER's and CR's and in the emplementation of AUS policy by mass support and action

(a) candidates with an organisational backing giving them the capacity to tour all campuses and produce publicity for distribution to all campuses would have an unfair advantage in "direct elections"

(b) the cost involved in conducting the electoral procedure are greater than AUS can bear

(c) consequently, the proposal would involve a massive increase in AUS fees and/or the conduct of elections by the Commonwealth Electoral Office

(d) the intervention of the Commonwealth Electoral Office would end AUS autonomy and directly pose the threat of Government interference in AUS affairs.

For this reason, the suggestion that the Commonwealth Electoral Office conduct AUS ballots is totally unacceptable.

MOVED: FINANCE COMMITTEE CHAIRPERSON.

SECONDED: SERVICES VICE PRESIDENT CARRIED

The above is policy passed at Annual Council 1977 moved to Constituent Ratification.
This ER requires in excess of 50% of exercisable votes cast against to be defeated.

Foreshadowed Motion - This will be voted on if ER 13:77 is lost. "That national student officers be directly E.R.14:77 elected by students. That in addition to normal nomination procedures, the following be regulations governing these elections: i) there shall be a special election supplement of National U, including in it a list of candidates in order of ballot, policy speeches, curricula vitae, photographs of candidates, speeches on behalf of candidates from two members of the Union, including one from a Constituent-Organisation of which the candidate is not a member; that all candidates shall be given the opportunity to answer questions-posted in questionnaire/interview form, common\_ for all candidates, the contents to be determined by the Media Officer(s) in consultation with the Executive, with a view to increasing information available to students about the qualifications and experience of candidates; (i) that nominations shall close at least four week prior to the commencement of the election period; iii) that from the time of the close of nominate ions until the completion of the election, no editorial or other comment on individual candidates or policies shall be published or distributed in National U, local campus media or in other form; iv) that no person or organisation in connection with any election shall expend any money in electioneering; that each Constituent Members shall appoint a Local Returning Officer who shall be responsible through the Regional Organiser to the National Returning Officer for the proper conducting of the election at that constituent; vi) ballot pepers shall be printed by constituent members, and all papers issues shall be initialled and numbered by the L. Returning Officer or duly appointed deputy; number of votes shall be recorded and students voting shall sign a book; such that number of signatures shall equal number of votes cast; and ballot papers and signature book shall be kept for four weeks, which shall be the period for lodging of, complaints and disputes; vii) the Regional Organiser, in the first instance, and the National Returning Officer with the Executive, as court of appeal, shall rule on complaints and disputes; viii) polling shall be open for five (5) academic days on each constituent, at the regular locations of polling booths on each constituent campus, as provided in Constituent Regulations, or custom;

- ix) all-Returns shall-close two weeks after the opening of the national voting period;
- x) consituents shall be reimbursed for polling clerk expenses, according to a formula determined by the Executive; other costs shall be borne by constituents."

The above motion was moved by Melbourne University for Extraordinary Resolution. For this to become policy of the Union, it will require a majority of votes cast to be in favour, providing that an absolute majority of exercisable votes have been cast.
